The above sanction is subject to fulfilment of the following conditions :—

1. The School will follow syllabi and courses as per scheme of studies prescribed by the Board for Secondary School Examination and changes made therein from time to time.
2. The school shall appoint only qualified and eligible staff.
3. The school will help the Board in the smooth conduct of the examination by placing the necessary accommodation i.e. Halls, Rooms available in the school premises and furniture at its disposal for holding its examinations free of charge, if required to do so.
4. The school will spare sufficient teachers for invigilation purpose at the examinations of the Board as may be required by the Board.
5. The school will spare its teachers for evaluation of answer-books for the Board's examinations, if required to do so.
6. The school will provide Laboratories, Library and other facilities as per norms of the Board.
7. The school will abide by the conditions of affiliations already prescribed or may be prescribed by the Board from time to time.
8. Annual fees @ Rs 500/- per annum for the years.....1997-2000.....be also remitted at an early date.
9. Code No. allotted to your school is.....21773.....This may please be noted and quoted for any correspondence with the Board. Original Receipt Nodt.....for Rs.....is also sent here with for office record.

10. The school will not sponsor candidates for Board's examination of any other school/Branch which is not affiliated to the Board.

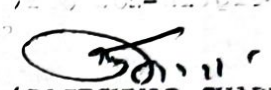
11. The school will create Reserve Fund as per the requirement of the Affiliation Bye-Laws/Rules of the Directorate of Education Delhi in the joint names.

CONDITIONS FOR FRESH PROVISIONAL AFFILIATION

- ✓ 1. The construction work of the school building is completed within One year or Upgradation to + 2 stage.
 - ✓ 2. The Science lab/library facilities are further strengthened considerably within 3 months.
 3. The campus area/~~campus~~ infrastructure will be exclusively used for the running CBSE school.
 4. 5-6 name of persons not below the rank of Principal of Sr. Sec. School affiliated with the Board be recommended so that two of them may be approved by the Board as its nominee in the School Managing Committee.
 5. The rate of DA may please be enhanced and the pay scales and allowances of the staff be revised from time to time to keep them at par with the approved rates of the State Govt.
 6. The service conditions be strictly followed as per State Education Act and staff be given appointment/confirmation letters etc. accordingly.
 7. A sum of Rs.60,000/- be deposited in the Joint names of the Chairman, CBSE and the School Authorities and a photocopy of the F.D.R. be supplied to this office.
 8. The School will not open/continue with any branch of the school without permission.
 9. The school will not open class XI/XII in the school without permission.
 10. The adequate number of TGTs i.e. 1.5 per section be appointment/promoted within 3 months.
- A Compliance Report on above points be submitted within 3 months with documentary evidences.
